The U of A Pennant Team Challenge

- Teams are invited to compete for the **2007 U of A Pennant**.
- Teams are 5 members (4 male & 1 female).
- Each male/female team member must be from a different weight category.
- Each team must consist of at least 3 males and 1 female from the same club.
- If a team is short 1 male or female from their club, the respective coach can make a request for approval of an addition competitor that is not registered with their club to a maximum of 1 competitor. A majority vote of the team coaches will decide whether to allow the non-club member to fight for the respective club.
- A team can consist of less than 5 members, but will lose each match they do not have a competitor in.
- You have to participate in the individual competition in order to compete in the Team Challenge.
- Format for the draws will depend on the number of entries received.
- Teams may be submitted the day of the tournament.
- Matches will be from the lightest female to the heaviest male weight class.
- Matches will be 3 minutes in length.
- Winner will be decided by team wins. If teams are tied for wins, (ie: one match is a draw), then total team points, based on individual points per win, will then determine the winning team.

 WAZA-ARI – 7pts
 YUKO – 5pts
 KOKA – 3pts
