Referee Clinic: **9:15 a.m.**

Entry Fee: **\$35.00** per entry if mail, fax and e-mail entries received before November 19th, 2008. For any late phone, fax and e-mail entries - **\$40.00**.
No entries will be accepted on Tournament day.

We will make every effort to accommodate Novice and Intermediate girls in separate categories depending on the number of entries in these divisions. Novice divisions and categories will be created if there are sufficient competitors.

The Tournament Director reserves the right to alter the weight divisions if the number in these divisions warrants such changes.

Elimination: Modified double elimination. Divisions with less than 5 contestants will compete in a round-robin format with wins counted first, then points. If there are only 2 competitors in a division, it will be best two out-of three.

Medals: Medals will be awarded for first, second and third place. All medal winners must win at least one match.

Eligibility: All participants must be members in good standing with their respective judo associations. Proof of valid membership may be requested at the weigh-in.

Out of Province: All out of province competitors will be required to submit a waiver form. This is to be signed by a parent or guardian for those competitors under 18 years of age.

Rules: Shime-waza or kansetsu-waza are permitted in the U-17 and U-20 divisions only. They are NOT permitted in the U-15 or younger divisions 1 to 5. The Referee shall stop the match in the following situations in U-15 or younger divisions:

- when shime-waza or kansetsu-waza is attempted,
- when a “head-lock” throw and “drop seoi nage” is attempted.

I.J.F. Rules will apply, except for the following:

- Any contestant is entitled to a rest between contests for a period equal to the match duration of his or her previous match.
- Old Medical rule will apply for all divisions except U-17 and U-20 divisions. New Medical rule will apply U-17 and U-20 divisions.

Weigh-In: All contestants must report to the weigh-in at the scheduled times on **Saturday, Nov. 22th at the tournament site.**
See Division categories for weigh-in times.

A penalty fee of \$5.00 will be charged to any contestant who fails to qualify for his or her entered weight division.
