**Judo Alberta Tournament Sanction Policy
POLICY #2-03
Revised November 9, 2012**

INTRODUCTION

This Policy is supplemental to Judo Canada's Sanction Policy and is provided as an addendum to that document.

The purpose of this document is to:

- establish the requirements for sanction by the provincial sports governing body for judo.
- standardize the operation of tournaments in the Province of Alberta.
- ensure that the event is conducted in accordance with a specific set of rules.
- ensure that the event will be of high standard and safe.
- ensure that the referees are qualified and in good standing.
- comply with the Judo Canada Sanction Policy.

IT SHOULD BE NOTED THAT THE FAILURE TO MEET THESE REQUIREMENTS MAY RESULT IN WITHDRAWAL OF SANCTION AT THE DISCRETION OF THE JUDO ALBERTA SANCTION COMMITTEE.

Clubs proposing to sponsor a tournament must be members of Judo Alberta and should be aware that if the event is not sanctioned:

- it will not be valid for the calculation of points toward grading.
- it will not be valid for selection purposes.
- no grants of funds will be available.
- no technical support will be available.
- referees and other officials who are members of Judo Alberta will not be allowed to participate.

GENERAL REQUIREMENTS

1. Applications for sanction are to be forwarded to the Sanction Chairman 8 weeks prior to the event. The tournament invitation is to be forwarded prior to distribution to the invited clubs. In addition, the event organizers must contact the Chairman of the Referees Committee at least 4 weeks prior to request the appointment of a Chief Referee. The Sanction Officer will forward the approved invitation to Judo Alberta for posting on Judo Alberta's website. Once a sanction number has been generated, the LOC can distribute the package to their contacts.

2. Participation in a sanctioned tournament is restricted to the rank of Gokyu (yellow belt) and higher. There is to be no white belt participation.
3. All weights are naked weight; but, contestants may weigh-in wearing undergarments/swimsuit. The weigh in should take place on the morning of the event for a provincial points tournament.
4. A contestant may not compete in an age/weight division other than the one in which he/she qualifies for that event, except for the Grand Champion. Exhibition matches may be included but the contestants must mutually agree to participate. A contestant under the age of 18 will not be allowed to participate in an exhibition match without legal consent.
5. Males and females may not compete against each other in shiai except for the U9 & U11 divisions. This rule does not apply to Kata competitions.
6. All contestants and participants must be registered members in good standing with Judo Alberta, Judo Canada, a provincial/territorial association recognized by Judo Canada or an IJF recognized association. Proof of membership and date of birth must be produced upon request.
7. An opening ceremony prior to the commencement of the tournament shall include, in addition to any other matters desired by the tournament sponsors, an introduction of Judo Alberta Executive members present, introduction of referees (if time permits) and a formal bow in. A formal closing may follow.
8. The date of the event is subject to approval of Judo Alberta's Sanction Chairperson.

EVENT CATEGORIES

Local ~ City only

Regional ~ City, including an adjacent Zone

Provincial ~ including north and south

Interprovincial

International

For Provincial Championship, the age and weight divisions listed are compulsory. For Provincial, Interprovincial and International events, age groups in the U13, U15 & U17 divisions may be deleted, but the weight divisions must be adhered to. For Local/Regional events, variations in the belt, age and weight divisions will be permitted at the discretion of the Sanction Chairperson. In addition, Clubs may host a Demonstration where white/white-yellow belts may demonstrate with other white/white-yellow belts provided that each and every white/white-yellow belt can satisfactorily perform ukemi.

WEIGHT DIVISIONS (IN ACCORDANCE WITH JUDO CANADA SANCTION POLICY)

Age Categories – The age of the competitor is determined by their age as of December 31 of the year of the following national championships, not the date of the tournament.

Weight divisions set by Judo Canada sanction policy.

BELT DIVISIONS

All divisions must be a minimum of Gokyu

Veterans - discretionary

Senior Men - Nikyu and under, Ikkyu and up; or Nikyu and up (if desired)

All other divisions are set by Judo Canada sanction policy.

TEAM COMPETITION

A team consists of a minimum of 5 contestants/team. Team contestants must compete in their own weight category or in

the next division higher.

Scoring procedure:

Win by Ippon – 10 points

Win by Waza ari – 7 points

Win by Yuko – 5 points

Hiki Wake – 0 points

The winner of the match will be awarded points for his team as above. The loser will not receive any points. The team with the greatest number of wins at the conclusion will be declared the winner. In the event of a tie in the number of wins, the team with the greater number of points will be declared the winner. In the event of a tie in the number of wins and number of points, each team will select a contestant to compete in the tie breaker.

KATA COMPETITION

As Kata is part of the judo syllabus, it should be included, where appropriate, as part of the competition in a tournament. Kata shall be included as part of the competition in the Provincial Championship and include as many of Nage-no-Kata, Katame-no-Kata, Goshinjitsu-no-Kata, Ju-no-Kata and Kime-no-Kata as are possible. In the event that only one team is available, the kata should be demonstrated.

MATCH ELIMINATION AND DURATION

Individual competition is to be determined by the Tournament Chair.

2 contestants—best of three matches.

3 contestants—single round robin

At the discretion of the Tournament Chairperson, single round robin competition can be used for divisions of up to 5 competitors only.

Match times are set according to Judo Canada Sanction Policy.

Team competition - single elimination of team.

AWARDS

For divisions U13 and up – medals, trophies or ribbons are to be awarded for first, second and third place. The awards are to be consistent and equal regardless of the division.

For divisions U9 and U11 – awards must be given to all contestants.

Contestants should be in judogi or provincial team uniform to accept an award. Where the competitor has refereed at the tournament after competing (usually in Kata or Masters divisions), a standard Referees' uniform is acceptable apparel for receiving an award.

CONTEST RULES

IJF Contest Rules apply to Provincial, Interprovincial and International tournaments. Where any variations from IJF standard rules are to be used, they must be stated.

NOTE: The simple statement "IJF rules apply" requires that blue judogis be worn and the "Golden Score" (sudden death overtime) will be followed.

For Provincial Championships, blue judogis are mandatory for Senior Men in the brown and black belt divisions and for Senior Women of blue belt and up.

It should be noted in the invitation if the blue judogi is mandatory or not. The second name called must wear a blue judogi.

MEDICAL

Judo Canada's Sanction Policy outlines all required medical coverage.

LEGAL

The proper completion of a properly drafted Release form is essential in view of the potential for lawsuits. The forms attached to this Sanction Policy are to be used in all sanctioned tournaments in the province. A competitor who does not have a properly completed form will not be allowed to compete. This form must be signed by anyone 18 years of age and over. The form for persons under the age of 18 years may require some explanation (see attached forms for signing procedures).

The Tournament cannot shift a competitor into a different weight division without legally acceptable permission (as in the case of tournaments where there may not be enough competitors in a specific grouping). If the competitor is of legal age of majority, they may agree or disagree themselves. If the competitor is a minor, they may be shifted to a new category only if their parent(s) or guardian(s) agrees to the change. If minors come to the tournament without authorization to change categories, the liability waiver is interpreted as being specific to the weight division in which they originally qualify.

POST TOURNAMENT REPORTING

A list of all award winners is to be forwarded to Judo Alberta's office and Provincial Coach within 2 weeks. A list of all referees who officiated at the event is to be forwarded to the Chairperson of the Referee Committee within 2 weeks. Upon request, copies of the draw sheets are to be forwarded to the Provincial Coach.

SUPPLIED BY JUDO ALBERTA

1. The Chief Referee and all supporting referees and judges.
2. Designated Sanction Advisor.
3. Awards for Provincial Championships.

SANCTION COMMITTEE

At any sanctioned tournament in the Province, the Sanction Committee shall consist of the Sanction Chairperson (or designate), the Chief Referee and either a member of the Executive Committee or the Technical Committee.

The Sanction Committee may meet for the purpose of determining whether the tournament meets the requirements of the Sanction Rules. The Tournament Director may make representations at this meeting. The sanction for a particular tournament may be withdrawn only if approved by a majority of the Sanction Committee.

SANCTION FEE

The applicable sanction fee must be submitted with the Sanction Application for Judo Alberta's Sanction Officer to consider sanctioning a tournament.

GRAND CHAMPION

Grand Champion is only held at the Senior Provincial Championship. Each contestant in the Grand Champion must be 18 years of age or older and placed 1st in their weight division. If the winner of a particular weight division is under the age of 18 years, there will be no contestant in that weight division. Matches are to be 3 minutes, single elimination.

For men, the Grand Champion is for Yudansha and ikkyu only. Men in the -60 kg, -66 kg and -73 kg weights compete as a group and the -81 kg, -90 kg, -100 kg and +100 kg men compete as a group. The two group winners will compete for the title of "Grand Champion".

Where a female Grand Champion is to be held, the women will be ranked gokyu and higher. Women in the -48 kg, -52 kg and

–57 kg categories will compete as a group and the winners of the –63 kg, -70 kg, -78 kg and +78 kg categories will compete as a group. The two group winners will compete for the title of "Grand Champion".

MINOR
(Under 18 years old)

RELEASE, INDEMNITY, WARRANTY, REGISTRATION AND ASSUMPTION OF RISK

In consideration of the acceptance of the entry of _____ (hereinafter referred to as "the said child") to compete in and/or being permitted to participate in the _____ (hereinafter referred to as "This event"), I/we for myself/ourselves and for and behalf of the said child hereby release, remise, and forever discharge and agree to indemnify and save harmless the Alberta Kodokan Black Belt Association , _____

_____, their respective organizers, officers, executives, directors, officials, agents, servants, sponsors and representatives (hereinafter referred to as "the releasees") from and against all claims, actions, costs, expenses, and demands in respect of death, injury, loss, or damage to the person or property of said child, or myself/ourselves, however caused, arising out of or in connection with the said child competing, or participating in this event and notwithstanding that the same may have been caused by, contributed to or occasioned by the negligence , breach of contract, breach of a common duty of care as an occupier of premises or otherwise, of or by the releases or any of them.

I/We agree to assume all risks, both known and unknown, and all consequences thereof, for me/us and for and on behalf of the said child, arising out of or in connection with said child competing or participating in this event.

I/we agree for myself/ourselves and for and on behalf of the said child to adhere to all rules, regulations and conditions of this event.

I/We agree to allow the said child to participate in one weight division higher than his/her actual weight if there are insufficient competitors in either division and as guided by Judo Alberta's Sanction Policy. He/She may partake in exhibition matches one weight division higher than his/her actual weight.

I/we hereby register the said child as a competitor or participant in this event and I/we certify that: The said child is in good physical condition and has no injury, disease or disability that would impair his or her performance or physical condition or increase the likelihood of injury in competing or participating in this event.

No physician, nurse, therapist trainer, coach, manager, or other person has advised me/us not to allow the said child to compete or participate in a body contact sport or in this event.

I/we am/are familiar with the sport of judo and the nature of a judo contest. I/we am/are aware that there is a risk of injury by the very nature of the sport. We are the father and mother of the said child or the guardian(s) of the said child and the only person(s) lawfully entitled to act for and on behalf of the said child. This document shall be binding upon the said child, me/us, the heirs, executors, administrators, assignees and personal representatives of each of us and the said child.

I/we have read this document and I/we agree that the said child and I/we are bound by its terms. I/we further understand that it is compulsory and mandatory that this document be fully completed and signed as a condition precedent to the said child competing or participating in this event.

I agree to participate in one weight division higher than my actual weight if Tournament organizers deem that there are insufficient competitors in my actual weight division and as guided by Judo Alberta's Sanction Policy. I may partake in exhibition matches at my actual weight or one weight division higher.

I agree to assume all risks, both known and unknown, and all consequences thereof, arising out of or in connection with my competing or participating in this event. I agree to adhere to all rules, regulations and conditions of this event.

I CERTIFY THAT:

- I am in good physical condition and I have no injury, disease or disability nor have I injected or ingested anything that would impair my performance or physical condition or increase the likelihood of injury in competing or participating in this event.
- No physician, nurse, therapist, trainer, coach, manager or other person has advised me not to compete or participate in a body contact sport or this event.
- I am familiar with the sport of Judo and the nature of a Judo contest. I am aware that there is a high risk of injury by the very nature of the sport.

THIS DOCUMENT SHALL BE BINDING UPON ME, MY HEIRS, EXECUTORS, ADMINISTRATORS, ASSIGNS AND PERSONAL REPRESENTATIVES.
